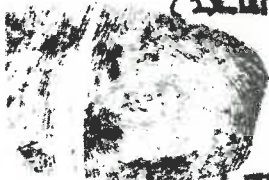

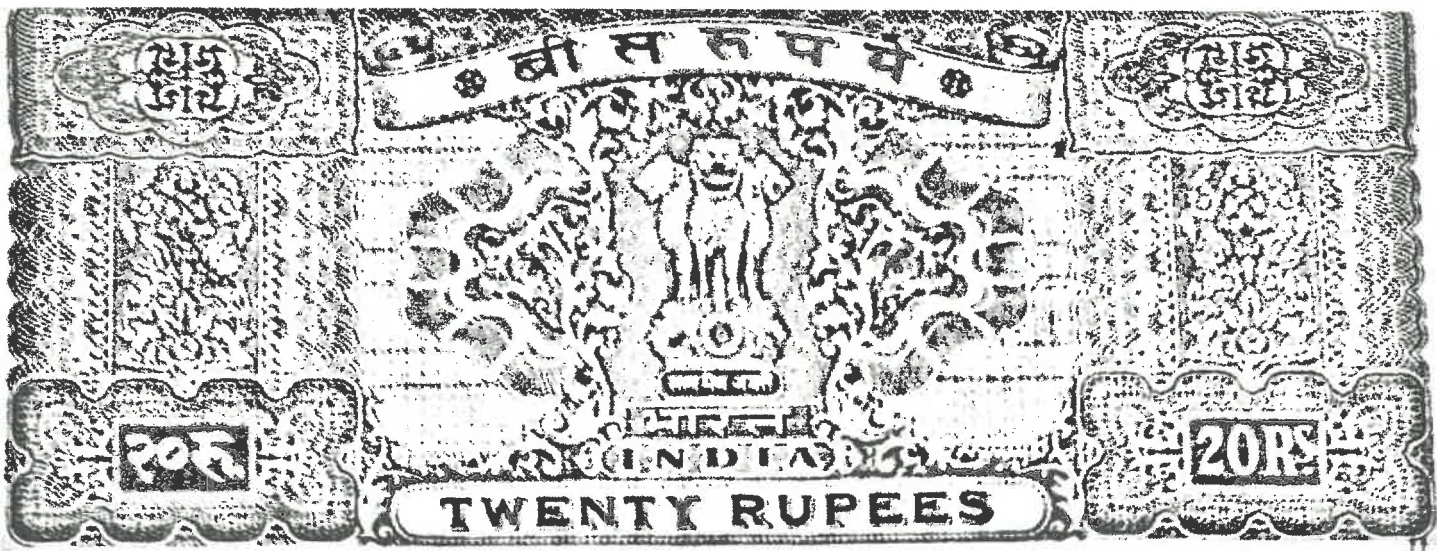

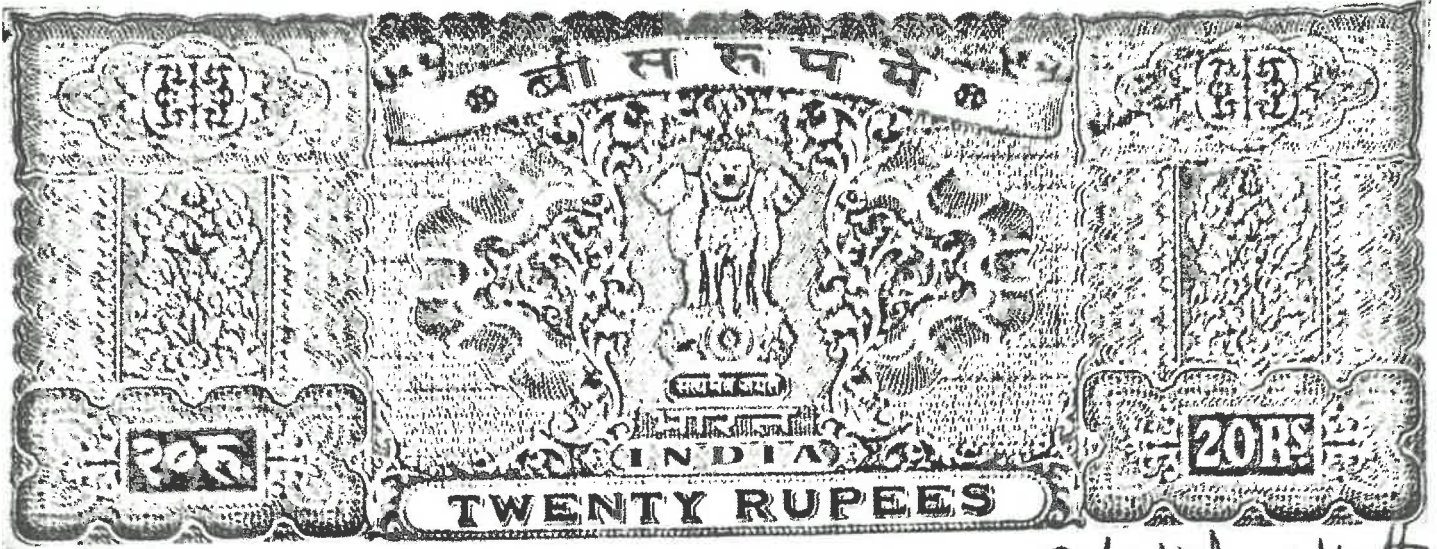

- 2) And the benefits of the trust and Trust funds, Properties, things and accretions thereto shall at no time revert to the Trustees or to their heirs, administrators, executors, legal representatives or to any of their close relatives.

IV. MANAGEMENT OF THE TRUST

- 1) The trust shall be administered by a Board of Trustees whose number shall not be less than 3 or more than 5. The three founder trustees shall be the permanent trustees, the remaining shall be co-opted or nominated by the permanent trustees and these shall be called nominated Trustees.
- 2) The trustees shall elect among themselves the following office bearers: the Chairman, Secretary and Treasurer.

V. TERMS OF OFFICE:

- 1) The term of the permanent trustee shall be for life. The terms of office in the case of nominated or co-opted trustees shall be for one year. However they are eligible for re-appointment. The term of office of the office bearers shall be for one year.
- 2) Any body either office bearer or co-opted/nominated trustees who is found to act against the interest or against the objectives of the trust could be removed from the office by a no-confident motion.

VI. VACANCIES:


A Trustee shall cease to be in office with immediate effect on his becoming insolvent or insane or of being convicted for any offences involving moral turpitude or on resignation/retirement/death/otherwise.


Any vacancy occurring in the office of the Trustees whether permanent or nominated including those caused by retirement, death or otherwise shall be filled up by the permanent Trustees with the consent of majority of permanent Trustees, the existence of vacancies in the Board of Trustees shall not invalidate any act or decision by the Board of Trustees.


VII. POWER OF TRUSTEES:

The founder Trustees shall have the absolute power to reconstitute/alter/change/include the member in the Board of Trustees. The trustees shall have full power and authority to administer the Trust property and expedient to promote or further the objects for which this Trust is created and shall be entitled to act notwithstanding any vacancy in the Board of Trustees.

(1) The Trustees shall at their absolute discretion exercise powers without violating any law and subject to the provisions of the Income Tax Act regarding exemption of tax in accepting the funds by way of donations, gifts, contributions, subscriptions etc. Upon such terms and conditions as they

may think fit or upon such terms as the donor may stipulate which are acceptable to the trust in the form of cash, cheques, drafts, shares, Debentures, Securities, Hundis, Bills, or Exchange, Negotiable Instruments or other movable properties and immovable properties other properties in any form whatsoever provided always that the terms and conditions upon which such donations Gifts, contributions, etc., accepted shall not in any way be inconsistent with or repugnant to the object of the Trust and the provisions made herein. The Trust shall also have power to raise to receive or collect funds for the Trust in such other manner or ways and means as the Trustees may decide from time to time provided that the Trust shall not contravene the provisions of the objects clause.

(2) To acquire by purchases, grant, gift, Exchange, lease, hire or otherwise lands, buildings, stocks, shares, securities, movable and properties of every other description.

(3) To accept in cash or kind contribution, gifts or donations from any one or from agencies within India and from abroad and from Trusts which have objects similar to this Trust.

(4) To sell, mortgage, grant or lease, hire and otherwise alienate all or any of the properties of the Trust.

(5) To enter into all contracts on behalf of the Trust and rescind.

- (6) To borrow money with or without security for the advancements of the objects of the Trust and repay the same.
- (7) To open accounts in banks and provide for their operations by one or more of the Trustees as may be decided by them from time to time.
- (8) To accumulate income of the Trust in the manner and to the extent permissible under the Income-Tax Act and to invest the funds of the Trust not immediately required for the purpose of the Trust in such manner so they deem fit and the investments shall be in accordance with the provisions of section 11 to 13 of I.T. Act. The Trust shall also be at liberty to invest the surplus funds in the purchase or mortgage of the immovable properties for the Trust.
- (9) To receive collect and enforce recovery of all moneys due or payable to the Trust and grant necessary receipt and discharge there for.
- (10) To appoint, terminate, suspend and otherwise and deal with employees.
- (11) To appear and act before courts, tribunals, public office etc.,
- (12) To institute, Prosecute and defend all suits and other legal proceedings.
- (13) To incur all necessary expenses from the corpus or income of the Trust in connection with the Trust and its management and for its institutions.

(14) To apply properties and funds of the Trust for the objects of the Trust.

Generally to do all such acts, deeds and funds as may be required to fulfil the purpose of the Trust and matters incidental thereto.

VIII. TRANSACTIONS OF BUSINESS:

The Trustees shall meet atleast once in 3 months or as often for the efficient carrying out of the affairs of the Trust. Such meeting shall be presided over by the Chairman of the Trust or in his absence any Trustees among those present, elect one Trustees to preside over the meeting. All decisions of the Trust shall be by a simple majority except as otherwise expressly provided therein. The Chairman of the meeting shall be entitled to a casting vote in the event of equality of votes at the meeting.

The notice of such meeting shall be sent by the managing Trustee/Secretary granting atleast seven days time to attend the meeting.

Three (3) Trustees shall form the quorum for the meeting and the decision taken in such meeting shall be final and binding on the Trust.

All correspondence shall be carried out in the name of the Trust under the signature of and by the managing Trustees/or Secretary, who shall carry on day-to-day transaction by himself and through staff and shall also maintain the record of minutes of the meetings and other correspondence.

IX. ACCOUNTS AND AUDIT:

The Trust shall keep or cause to be kept proper Books of Accounts of the receipts, income and expenditure of the Trust and the Trust properties. The Accounts shall be got audited by an Auditor every year. For this purpose the year shall be the financial year commencing from 1st April and ending 31st March of that year.

X. POWER TO MAKE RULES AND SUB RULES:

The Trustees shall be fully kept indemnified and harmless by the Trust against any action or claim, loss, suffered or liability arising against them on account of anything done by them in good authority conferred on them by these presents.

XII. RIGHTS OF THIRD PARTIES OR BENEFICIARIES:

In the event of the determination of the Trust, if this Trust should fail in any reason the Trustees shall make over or transfer the funds and properties of this Trust to any other Trust or Institution having object generally similar to those of this Trust and donation to which are exempt under section 10 (22) of the Income Tax Act, 1961.
